NOTIFICATION

The following Bye-Laws made by the Municipal Corporation, Shimla in exercise of the powers conferred by clause(6) of Part I of section 395, readwith section 35 and sub-section(3) of section 36 of the Himachal Pradesh Municipal Corporation Act, 1994 (Act No.12 of 1994) and having been approved/confirmed by the Governor of Himachal Pradesh are hereby published as required under section 397(1) of the said Act and they shall come into force within the limits of Municipal Corporation Shimla with effect from the date of their publication in the Rajpatra Himachal Pradesh, namely:-

- Short title. 1. These Bye-Laws may be called the Shimla Municipal Corporation (Facilities to Mayor, Deputy Mayor and Councillors) Bye-Laws, 1996.
- Definition. 2. In these Bye-Laws, the Himachal Pradesh unless the context otherwise requires:-
  - (i) 'Act' means the Himachal Pradesh Municipal Corporation Act, 1994 (Act No.12 of 1994)
  - (ii) 'Mayor' means the Mayor of the Municipal Corporation, Shimla elected under section 36 of the Act;
  - (iii) "Deputy Mayor" means the Deputy Mayor of the Municipal Corporation elected under section 36 of the Act;
  - (iv) "Councillor" means a Councillor of the Shimla Municipal Corporation and shall not include the Mayor and the Deputy Mayor;

(v) The words and expressions used but not denied in these Bye-Laws shall bear the same meaning as assigned to them in the Act.

Honorarium.

3. The Mayor and Deputy Mayor shall be entitled to an honorarium of Rs.2400/- and Rs.1500/- per month respectively. <sup>6500</sup> . . . 0

House Rent Allowance.

4. The Mayor and Deputy Mayor shall be entitled to a sum of Rs.2000/- and Rs.1500/- per month respectively, as house rent allowance irrespective of the consideration whether the residence is own or hired.

Sumptuary Allowance.

5. The Mayor and Deputy Mayor shall be entitled to a sum of Rs.1000/- and Rs.700/- per month respectively as sumptuary allowance.

Use of Car.

6. The Mayor shall be provided with a Chauffeur-driven motor car at the cost of the Corporation for use within the jurisdiction of Shimla Municipal Corporation for the discharge of his functions.

EXPLANATION:- "Cost" means the emoluments of Chauffeur, the cost of Petrol and Oil and maintenance of the vehicle.

Travelling Allowance.

7. For official journey(2) outside Shimla, The Mayor shall be entitled to travelling and daily allowances at the highest rates as admissible to Grade-I Officers of the Government of Himachal Pradesh.

Telephone.

8. The Mayor shall be entitled to the free use of a telephone in his office and residence, and he/she shall not be charged ~~call charges~~ for any official trunk call and local call from the office telephone and upto 2000 local calls per month from his/her residence telephone.

Councillors Allowance.

9. A Councillor shall be entitled to receive a fixed daily allowance at the rate of Rs.1200/- per month for attending any meeting or meetings of the Corporation or of any Standing Committee thereof.

X 11. The Shimla Municipal Corporation (Facilities for Mayor) Rules, 1986, The Shimla Shimla Municipal Corporation (Honorarium for Deputy Mayor) Rules, 1986 and the Shimla Municipal Corporation (Allowances of Councillor) Rules, 1986 are hereby repealed:-

Provided that such repeal shall not effect the previous operation of the said rules or anything done or action taken thereunder.
