
A meeting of Technical Evaluation Committee was held on 31<sup>st</sup> March 2021 at 11:00 AM under the Chairmanship of Additional Commissioner, Municipal Corporation Shimla for finalization of bids for leasing out ground floor of Town Hall, MC Shimla for High End Restaurant. The following Officers were present:

At the outset of the meeting, the Chairman welcomed all the Officers /participant bidders and apprised that following firms participated w.r.t. the NIT issued vide no. 2021\_MC\_45086\_1 Dated 4<sup>th</sup> March 2021 for leasing out ground floor of Town Hall, MC Shimla for High End Restaurant.

It was also apprised that out of above 7 (Seven) participants, 2 (two) participant firms namely M/s Twin tower and M/s Kufri fun campus have submitted their bids only in offline mode which cannot be considered as only offline bids were invited.



As per the terms and conditions of tender document, the technical and the financial bids were also required to be submitted in Two separate envelopes in the office of Municipal Corporation whereas M/s Manohar Lal Joshi has submitted his offline tender in single envelopes without superscribing it as technical or financial bid accordingly the same cannot be considered.

On scrutiny of online/ offline technical bids on 31.3.2021 & 01.04.2021, it was noticed that M/s GKE Hospitality, M/s Hotel Marina, M/s Hotel Comberemere and M/s Yudh Chand have not enclosed / uploaded prescribed tender document on online mode or on offline mode.

Since the bids for aforesaid work have been invited online and requirement of tender document of MC Shimla is mandatory in terms of bidder's acknowledgement for acceptance of all terms and conditions incorporated in tender document, particularly without putting signature in the tender documents as required at page no 10 of tender documents thus leading them technically not qualified.


In view of the above-mentioned facts and to ensure adequate competition as per the provisions contained in HPFR 2009 for leasing out ground floor of historical Town Hall, MC Shimla for High End Restaurant committee unanimously recommends to refloat the tender so as to ensure transparency and adequate competition.
